# **Terms Loyalty Program of MeblujemyDOM.pl**

dated 08.01.2014 r.

#### 1. Definitions

Terms and concepts used in these Regulations, unless the context otherwise requires, have the following meanings:

- 1.1. **Program** Loyalty Program, organized by MP STUDIO, functioning in accordance with these Regulations.
- 1.2. **Organizer** MP STUDIO established in Łęka Opatowska (63-645) at ul. Lipowa 14, Poland.
- 1.3. **Participant** an adult, with full legal capacity, which is involved in the program under the conditions set out in these Rules.
- 1.4. **Points** the points awarded by the Organizer to the Participant, according to the principles set out in these Rules.
- 1.5. **Discount** benefit expressed as an amount or percentage which the Participant, receives in exchange for the designated number of points taken from the Individual Account.
- 1.6. **Individual Account** an online account where points are recorded and which is assigned to the Participant.
- 1.7. **Online Shop** website www.meblujemydom.pl.
- 1.8. **Order** the purchase of products from the Shop made by the participant by telephone, e-mail or through a virtual shopping cart on the Store.

#### 2. General

- 2.1. Program is designed to reward discounts Participants who make purchases online store MeblujemyDOM.
- 2.2. Program operates on the territory of the Republic of Poland.

### 3. Conditions for participation in the Program

- 3.1. The Program is open to any adult person, with full capacity to act.
- 3.2. The Condition of the Program is to register an account on the store Organizer.
- 3.3. After the Participant activities referred to above, the e-mail address provided by the Participant in the registration form will be sent containing a link to verify. When activated the verification link, the Participant will be informed of the confirmation of the correct registration.

- 3.4. Individual Account of the Participant becomes active when the participant successfully completes the registration process. From that moment on participant collects points on your Individual Account on the principles set out in the Regulations.
- 3.5. For one participant may be carried out only one Individual Account. There is no possibility of transferring the Individual Accounts of another person.
- 3.6. Participation in the program is free of charge.
- 3.7. Administrator of personal data Participant is Organizer.
- 3.8. Organizer processes personal information Participants given in the application form and other, given by the Participant after joining the Program solely for purposes related to the implementation of the Program on the terms specified in the Regulations.
- 3.9. Participants have the right to access their personal data and the possibility of correcting them.

#### 4. Collection points

- 4.1. Points are collected for the Participant's Individual Account.
- 4.2. Each Participant receives Points after the purchase in the Online Shop Organizer.
- 4.3. Points are earned on the date of execution of the Order (issue sales receipt or invoice from Organizer).
- 4.4. Points are earned for the purchase of any products from the Store, including those covered by the current promotions.
- 4.5. Points are a percentage of the Order. Each license issued 5 zł gross in the store is 1 point.
- 4.6. The Participant also receives Points for:
- 4.6.1. Subscribe to our newsletter database once receive 100 points.
- 4.6.2. Feedback left for the products purchased. Each approved by the Organizer opinion is 10 points.
- 4.7. Participant may at any time check Points after logging into your account.

## 5. Exchange of points

- 5.1. The Participant can choose one of three options exchange Points:
- 5.1.1. Buying goods from Shop for accumulated Points. Each 7 (seven) Points to 1 zł value of the product.
- 5.1.2. Exchange Points for Discount quota, respectively, with a value of 150 zł for 1000 pts., 400 zł for 2000 pts., 1000 zł for 4000 pts. and 2000 zł for 6000 pts. Discount coupon is possible to use the additional purchases in the Store and can provide up to 50% of the orders.

- 5.1.3. Exchange Points for permanent Discount percentage, respectively, with a value of 3% for 2000 pts., 5% for 4000 pts. and 7% for 6000 pts. Percent Discount will be assigned to the Individual Account for a period of 36 months.
- 5.2. Realized for the purchase of products or their exchange Points for Discounts will subtract the appropriate amount of the Individual Account points and results in a change of the balance point.
- 5.3. Accumulated Points can't be exchanged for cash.

### 6. Final Provisions

- 6.1. The Organizer reserves the right to change the quantitative thresholds required to exchange Points for coupons or Discounts permanently. To change the calculation of Points Organizer will inform the Participants.
- 6.2. In case of technical errors related to the operation of the Program, Organizer reserves the right to suspend the calculation of Points and cancellation of accrued Points incorrectly.
- 6.3. Granting Points and exchange them for Discounts shall be in accordance with applicable at the time the Program Rules.
- 6.4. Using knowledge of the Loyalty Program and confirm your acceptance to these Terms and Conditions.
- 6.5. These Terms and Conditions shall be valid for the introduction of the new changes.
